Hot holding temperatures</p> <p>-Observed Pasta and Rice in serving line with temperatures of 124°F . all food in serving line must be maintained with correct hot holding temperature of at least 135°F. The manager replaced the food with another that was in the oven complying with the correct hot holding temperatures. (COS)</p> <p>CODE REFERENCE: 64E-11.003(2). PHF/TCS foods, which are held hot and not subject to an approved HACCP plan, must be maintained at 135°F.</p>
<p>Violation #47. Food & non-food contact surfaces</p> <p>-Warmer equipment at the service lines must be examine / replaced as they are not keeping the food at correct hot holding temperatures. At the time of the inspection the warmer was on maximum level and food was below 135°F.</p> <p>CODE REFERENCE: 64E-11.003(4). Equipment and utensils must be properly designed, constructed, and in good repair.</p>
