Violation #55. Facilities installed, maintained, & clean

Observed ceiling tiles stained at cafeteria dining area. Replace ceiling tiles.

Observed loose HVAC vent in dining area. Repair A/C vent.

CODE REFERENCE: 64E-11.003(5). Floors, walls, and ceilings shall be smooth, durable, easily cleanable, and non-absorbent. Exterior areas shall be kept cleaned.
