Homelessness	The school works closely with Project Up-Start and other agencies to provide support to families in transition. With their help, we have been able to provide our students with backpacks, uniform vouchers, transportation, and other resources made available to them.
Work Scheduling Conflict	Meeting times are flexible, in order for parents to have more opportunities to attend school activities. The school offers online workshops via Zoom, phone conferencing, and in-person meeting before, during, and afterschool hours. Teachers use communication apps such as Schoology and Class Dojo.
